Waiver of Liability

1. The Australian Alpine Club Falls Creek Inc (AACFC) has put in place a number of preventative measures to reduce the spread of COVID-19. However, the Club cannot guarantee that you, your Guests or anyone else will not become infected with COVID-19. Further attending the Club could increase your risk of contracting COVID-19.
2. The Club has developed a COVID Safe Plan to implement those guidelines and other government directions and recommendations. You must familiarise yourself with this plan, which is available at <https://aacfallscreek.com/pdf/aacfccovidsafeplan.pdf>. You must familiarise and comply with that plan and ensure your Guests do the same. (Guests includes all members of your party, including family.) You must also comply with any direction from the Lodge Manager.
3. You must also comply with all Federal and State Government social distancing requirements and guidelines .
4. You are also responsible for ensuring that all your Guests comply with all COVID-19 requirements.
5. Any breach or non-compliance with any COVID-19 requirements may lead to a direction being issued to you and/or your Guests by the Lodge Manager or an AACFC committee member to immediately leave the premises. If such a direction is issued you must comply with it.

You voluntarily agree to assume all of the foregoing risks and to accept the sole responsibility for any injury to you or any of your Guests which may experience or incur in connection with attendance at the Club's premises. You hereby release, discharge and hold harmless the Club, its employees, agents and representatives of and from any claims including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. You understand and agree that this release includes any claims based on acts, omissions or negligence of the Club, its employees, agents and representatives whether the COVID-19 infection occurs before, during or after your attendance at any Club premises.

You further agree that you must immediately notify the Lodge Manager if you or any of your Guests display any flu like symptom, or are advised by health authorities that they are a close contact of a COVID-19 case or that they are otherwise subject to Victorian government health directives regarding restricted movement, mandatory testing or isolation.
